  - 1. Remove "List 1" to be replaced with "as listed"

#### 2. Appendix 3:

- a. Planning Committee Terms of Reference:
  - i. Call In Additional wording to insert the ability of Members to call-in application by way of cross reference to Annex 4-8 - Code of Practice in respect of Planning Matters, paras 8.4 and 8.8, and
  - Applications made by Officers Rewording to cross reference to Annex 4-8, para 9 – Rather than all officers, limited to CMT (i.e. CEO, Directors and Heads of Service – and their spouses or partners)
- b. 1.2 & 1.3 Addition of "Vice Chair of Strategy and Resources" to both provisions.

#### 3. Annex 4-7:

- a. 1.3.8 the words "... have not been lobbied by any person in respect of it," are to be removed; further text is to be added to 1.8.1 to make it clear that whilst a Member will not be precluded from sitting on a Licensing Sub-Committee hearing an application with respect to premises within their Ward, they are expected to declare any lobbying attempts and that they maintain an open mind and are not predetermined in respect of the application after having been lobbied.
- b. 2.14.4 there is reference to 3.2(d); this shall be amended to 2.3.2 (iv)
- c. 2.14.13 there is reference to 8.5 and 8.12; this shall be amended to 2.14.4, 2.14.6 and 2.14.12
- d. 2.14.16 this shall be amended to include the words "The Chair shall relay the decision of the Sub-Committee, along with the reasons for its decision, orally to all parties at the hearing, and advise them of any rights of appeal."
- e. 2.15.3 this shall be amended to include the words "At the start of the Sub-Committee, the Licensing Officer will outline the background to the case and provide a summary of any updates or late supporting evidence received since the publication of the committee report, with each party then asked to confirm that this summary is correct."

#### 4. Annex 5-1:

 a. 17.11 - this shall be amended to include the words "Payment to co-opted members entitled to claim travelling and/or other allowances <u>in accordance with agreed</u> <u>policies</u>, will be made <u>through payroll</u> upon <u>receipt of an approved ITrent claim</u> or the prescribed form duly completed."

#### 5. Annex 5-2:

a. Amend CSO 27.2 and Section 6 of CSOs in order to reflect revisions to Annex 5-3 and the Scheme of Delegation; revised wording in red:

27.2 Contracts within Threshold 2 and 3 shall be the subject of a formal written Contract agreed in accordance with Annex 5-3 to the Constitution by the Chief Executive [DELEGATED] and under Seal if required by clause 27.3.
