To whom it may concern

I understand that you are the department responsible for considering the strip entertainment licence at the Stir club in East Street.

I would like you to realise that this club is important in ways you may not be aware of. I live [REDACTED] to the club at [REDACTED] and although I do not go into the club my brother [REDACTED] does. My brother is registered blind and relies heavily on his guide dog [name of dog]. When they come to stay with me my brother AND [name of dog] go to the club, and have done for several years. Actually even before I moved here.

Whilst many people will not understand why a blind person would go to such a place, it's very simple, if [REDACTED] and [name of dog] go to any other bar in Epsom, people (especially women) will avoid them and it is near impossible for [REDACTED] to engage socially. When [REDACTED] and [name of dog] go into Stir, they are made to feel very welcome and accommodated for with their own table. The women will happily spend as much time with [REDACTED] chatting and socialising as he wants. Yes I am aware he is paying for what he calls sit down time, but he cannot do that anywhere else. I was completely against him doing this to start with and so I went with him one night. I was amazed at how [REDACTED] is treated as a real guest inside the club and nowhere else have I seen him actually enjoy such normal social interactions that make him very happy, this is something the sighted community completely take for granted. I was also pleased to see what a normal bar this club is, there's never any trouble there that I am aware of and it causes zero disturbance even though it's open late, it's never really that busy. I understand people's reservations to this sort of thing but it's important that perceptions and prejudice do not take precedent over facts and reality. I am happy to support this club.

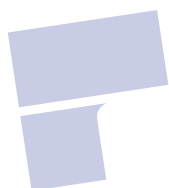

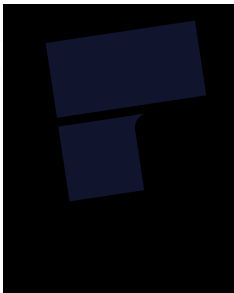
Please would you reconsider not renewing the license of Stir777, 4 East street Epsom

I am writing to express my strong objection to the renewal of the license for the sexual entertainment venue Stir located at 4 East Street, Epsom, Surrey on the grounds of prevention of crime and disorder and public safety.

Over the past number of months, there has been a significant increase in anti-social behavior associated with the establishment. Weekend nights at closing time, the noise level from patrons leaving the premises has become intolerable, causing a disturbance in the surrounding neighborhood. Additionally, there have been several incidents of fights occurring in the vicinity, posing a threat to public safety and well-being.

Before this period, the management of the venue seemed to handle such situations much more effectively, and there were minimal issues. However, the recent escalation of disturbances raises concerns about the current management's ability to ensure the safety and peace of the area.

I urge the relevant authorities to carefully consider the impact this establishment is having on the community.
