EBER ALAN KINGTON CITATION (As inscribed on the illuminated Scroll to be presented)

WHEREAS THE MAYOR, COUNCILLORS AND BURGESSES OF THE BOROUGH OF EPSOM AND EWELL in the County of Surrey acting by the Borough Council are enabled by virtue of the powers conferred upon them by Section 249 of the Local Government Act 1972 to confer the title of Honorary Alderman of the Borough on persons who have, in the opinion of the Council, rendered eminent service to the Council as past Members of that Council, but are not then Councillors of the Council:

AND WHEREAS CHRISTOPHER JOHN FROST, B.Sc. was first elected as a representative of the Stoneleigh Ward on 6 May 1999 which office he held for a period of four years and was then elected as a representative of the Nonsuch Ward on 5 May 2011, which office he held for a period of twelve years, serving on the Council for a total period of sixteen years during which time he gave devoted service to the Council and residents of this Borough
