11 DECLARATIONS OF INTEREST

No declarations of interest were made by Councillors regarding items on the agenda.

12 COMMUNITY GOVERNANCE REVIEW - CREATION OF COMMUNITIES AND COMMUNITY COUNCILS IN EPSOM & EWELL

Council received a report setting out the necessary steps and timescale required to create one or more new parishes and Communities and Community Councils through a Community Governance Review (CGR), as mandated by the Local Government and Public Involvement in Health Act 2007.

Councillor John Beckett **MOVED** and Councillor Rachel King **SECONDED** the recommendations in the report.

Upon being put, the recommendations were **CARRIED** as follows:

The Council resolved with 19 votes for, none against, 7 abstentions and the Mayor not voting to:

(1) Agree that a Community Governance Review be undertaken for the Borough of Epsom & Ewell.

The Council resolved with 16 votes for, 6 against, 4 abstentions and the Mayor not voting to:

(2) Authorise the Chief Executive and Head of Legal, in consultation with the Leader of the Council and Chair of Standards and Constitution Committee, to approve the Consultation Questions & Terms of Reference once final typographical changes have been completed and to take all and any necessary action to progress the Community Governance Review.
