Dear Licensing,

Surrey Police would like to address a point made within the application to Vary Licensing Hours for Epsom Grill.

The applicant has included in their application, that they have used 'several TENs in the past few years'. Below is a list of those TENs used by the applicant. I have included the reason for the TEN. Other than Bank Holiday TENs, all the others have been for Derby or Christmas. These are considered special events and therefore TENs around this time are taken with a lighter touch. These TENs have also included a SIA person from 23:00 till close. Derby TENs for the majority would have had a licensing officer working those evenings. Whilst I can confirm that activity took place, there were 3 incidents of Affray on 8<sup>th</sup> June 2025 02:15 near to the premises. It was not established if the persons involved were associated with the premises due to conflicting accounts.

- 23.00 31 May 2024 – 04.00 2 June 2024 (Derby. Abdullah GILGIL) x1 SIA
- 23.00 24 December 2024 – 04.00 26.12.2024 (Christmas. Bilal GILGIL) x1 SIA
- 23.00 30 December 2024 – 04.00 1 January 2025 (NYE. Bilal GILGIL) x1 SIA
- 23.00 20 April 25 – 03.00 21 April 2025 (BH. Bilal GILGIL) Notice received 08/04/2025 9 working days' notice
- 23.00 4 May – 03.00 5 May 2025 (BH. Bilal GILGIL) Notice received 22/04/2025 9 working days' notice
- 23.00 6 June – 04.00 8 June 2025 (Derby. Bilal DARI) x1 SIA. Notice received 29/05/2025 5 working days' notice

In RED are LATE TENs. LATE TENs are issued where the applicant has given less than 10 working days' notice to the Council. There were also 2 counter notices issued this year (25/05 and 06/06) both were for number of LATE TENs limit met by the applicant Bilal GILGIL. Having TENs does not necessarily show that the premises can run on a permanent basis on extended hours, as there would have been no advertisement to the longer hours to members of public. There is also concern that 6 TENs in 2 years are not 'several TENs', especially if they are looking to amended Friday and Saturday till 04:00 permanently. A premises may have up to 15 TENs or a total of 21 days per calendar year. It would be expected that the applicant makes use of the entire availability of TENs to bolster their evidence to



operate a premises at a later opening hour safely and under the objectives. This has not been done by the premises. For reference Surrey Police have not objected to a future TEN applied for by the premises to operate till 04:00 24<sup>th</sup> – 28<sup>th</sup> December. The reasons for not objecting fall in line with the reasonings above and the other granted TENs. These are only temporary hours and not permanent.
