24 MINUTES OF PREVIOUS MEETING

The Minutes of the Meeting of the Epsom and Walton Downs Conservators held on 8 October 2018 were agreed as a true record and signed by the Chairman.

25 MATTERS ARISING FROM PREVIOUS MEETINGS & OTHER ITEMS OF INTEREST

The Conservators received a report providing updates on the following matters: Maintenance of the hack sand track at the foot of Walton Downs; Bid for European Agricultural Fund for Rural Development funding (EAFRD).

The following further update was considered:

a) Bid for European Agricultural Fund for Rural Development funding (EAFRD). The Chairman informed the meeting that a site visit had now been held, and had identified elements which could be taken forward in the bid.

27 REPORT OF THE HEAD DOWNSKEEPER

The Conservators received the report of the Head Downskeeper. It included updates on the following matters: recent events on the Downs, staffing, incidents on the Golf Course and habitat projects.

a) **Publicity of habitat project work.** The Conservators greatly appreciated the habitat project work undertaken on the Downs and asked that it be given wider publicity where appropriate. It was noted that such publicity would need to be sensitive to the fragile nature of some of the species/habitats involved.

Following consideration, it was resolved:

28 BUDGET 2019/20

The Conservators received a report seeking approval for the 2019/20 budget and the recommended precepts on the constituent bodies.

The following matters were considered:

- a) **External Audit fee: year to date.** The Conservators noted a negative figure recorded for the External Audit charge for the year to date. The Chief Accountant informed the Conservators that this was due to an accrual, as the Auditor had not billed for their work before the end of 2018.
- b) Ad-hoc repairs to Tattenham Corner conveniences. Following a question, the Chief Accountant informed the Conservators that a cost for ad-hoc repairs to the Tattenham Corner conveniences had been incurred during 2018/19, but that no budget allocation for such works was considered necessary for 2019/20. If such costs were incurred again in the future, the position would be reviewed.

Following consideration, it was resolved:

(1) That the budget for 2019/20 be agreed as set out in Annex 1 to the report, with a request for a 4% increase in precept from the constituent bodies as follows:-

Epsom and Ewell Borough Council: £244,360

Epsom Downs Racecourse: £122,170

Epsom & Walton Downs Training Board: £40,730

29 EPSOM DOWNS RACING SEASON 2019

The Conservators received a report informing them of dates for race meetings in 2019 and presenting a request from Epsom Downs Racecourse for consent for race meetings and extensions to the periods permitted for fencing as required by the Epsom and Walton Downs Regulation Act 1984 and Epsom and Walton Downs Byelaws.

The following matters were considered:

- a) Fencing period extension applications. Simon Durrant informed the Conservators that the Racecourse was applying for two extensions to the period permitted for fencing. These extensions were unchanged from those granted by the Conservators for the 2018 racing season.
- b) Change to schedule of race meetings: 15 August, Team Racing. Andrew Cooper informed the Conservators of an amendment to the schedule of race meetings to be held in 2019. The provisional race meeting listed for Thursday 5 September would not take place. The Conservators were informed that an alternative evening fixture might be held on Thursday 15 August 2019 instead.

The Conservators were informed that if it was held, the fixture on 15 August would form part of a series of 'Team Racing' events held across the country over a number of consecutive weeks. The event was currently considered 'provisional' by the Racecourse, with confirmation of whether it would be held anticipated by the end of February 2019. The Conservators noted that as an evening fixture, it would require their approval in accordance with section 14 of the Epsom and Walton Downs Regulation Act 1984.

Following consideration, it was resolved:

(1) That the Conservators noted the dates of the 2019 racing season for Epsom Downs detailed in paragraph 1.1 of the report, and granted their consent to the following meetings in accordance with section 14 of the Epsom and Walton Downs Regulation Act 1984:

- (4) That the Conservators approved an application from Epsom Downs Racecourse for consent under the Byelaw 2 (i) (a) to extend the fencing period for the Lonsdale Enclosure to enable fencing to remain in place between the dates of 12 19 June 2019.

1 Items considered by the Training Grounds Management Board (TGMB)

1.1 The Training Grounds Manager (Mr Nigel Whybrow) has provided the following report on items considered at recent meetings of the Training Grounds Management Board (TGMB), for the Conservators information.

2 Cyclists on the Downs

2.1 The Board was informed that groups of cyclists using the Downs are becoming an issue for trainers. While social media posts seem to have helped in raising awareness, the Board felt more needed to be done to encourage cyclists to avoid the Downs until training had finished for the day.

3 Equine influenza

3.1 The recent outbreak of equine influenza highlighted some concerns regarding hacks that possibly were not vaccinated but were using the Downs. The Board is currently looking into this.

Report summary

This report presents the Head Downskeeper's update to the Conservators. It includes: Downskeepers' Hut break in, clearance of a fallen tree and new signs.

Recommendation (s)

(1) That the Conservators note the report of the Head Downskeeper.

1 Downskeepers' Hut break In

- 1.1 During December the Downskeepers Hut was broken into, with the door being badly damaged during the incident. Nothing was taken and there was no damage to the inside of the hut.
- 1.2 The front door and lock have been replaced, and under the recommendation of the Police any items of value have been painted with traceable DNA liquid, to deter further incidents.

2 Clearance of fallen tree

2.1 During recent strong winds a large tree came down and blocked one of the major bridleways across the Downs. The Ranger Service and Downskeeper team dealt with the situation with great professionalism. The implications of not getting the situation resolved quickly could have had effected horses in training and use by the public during the following week. I would specifically like to thank the Ranger team for their quick response and hard work.

3 New signs

3.1 New signage is soon going to be put in place at the main entrances leading onto Walton Downs. This is due to numerous vehicles being sent by Sat Nav systems through Langley Vale Farm onto tracks and bridleways on the Downs.

Report summary

1 Event Applications

1.1 Applications have been received from four groups/organisations for events on the Downs. Route maps for each of these events are included at **Annex 1**, and an event calendar for 2019-20 is included at **Annex 2**.

1.2 All applications have been made by organisations which have run the same or similar events in previous years. The table below details all of the above events.

- 1.3 The EDMAC Cloud Tramp event takes place on land designated for the club's activities and within the allocated times permitted for the club. The numbers are so low that little disruption is expected and so the event has been rated as category U. The event has previously taken place on the Downs over the past 20 years.
 - The Orienteering Event is expected to have very little impact on the Downs and other users of the Downs, and has therefore been rated as a category A.
- 1.4 The OMNI Terrier Derby event is expected to have very little if any impact on the Downs and other users of the Downs. Although the number of participants is relatively low the event itself does attract a much larger number of spectators and so has been rated as category B. This event has previously taken place on the Downs over the past 15 years.

- 1.5 The Surrey Men's Cross Country League and the Epsom College Cross Country Run event attract higher numbers of participants but are not expected to have much of an impact on the Downs and other users of the Downs and so they have been rated as category C. Both events have run smoothly on the Downs for a number of years and the organisers are very proactive to ensure minimal disruption to other users on the Downs.
- 1.6 The organisers of all approved events are reminded of the importance of staying on designated paths and not staying onto Training Grounds.
- 1.7 All organisations have provided the necessary paperwork, which includes copies of their public liability insurance and risk assessments.

2 Calendar of events

- 2.1 The calendar of forthcoming events is attached at **Annex 2**. The events shown in bold are for consideration by the Conservators at this meeting.


- 7.1 Each event on Epsom & Walton Downs is requested to submit a risk assessment and public liability documents when applying.





M4 Boys + Girls, U4 + 5th form Girls Cross Country route (1.7 miles)




<u>U4</u> + 5th form boys and senior girls Cross Country route (3 miles)








Senior Boys Cross Country route (3.3 miles)




Lower School Cross Country Route 2018 .5 miles


