### **Report summary**

The Draft Spatial Economic Development Strategy is a technical study commissioned by the Council to inform the emerging new Local Plan on the provision of employment land to meet the economic growth opportunities and options.

The Strategy identifies a number of priority interventions that would assist the borough to achieve longer-term economic prospects. The priority interventions set a strategic direction with projects identified that could come forward as part of separate business cases.

The Strategy identifies supporting measures including polices and development management guidelines.

The Committee notes the contents of the Spatial Economic Development Strategy 2020 as a technical study that will form part of the evidence base for the emerging new Local Plan.

  - 1.1 The Spatial Economic Development Strategy will form part of the evidence base for the emerging Local Plan policies. The delivery and implementation of the Epsom & Ewell Borough Local Plan will ensure sustainable growth is planned in the Borough to meet the Corporate Vision, priorities and values.

### 2 Background

2.1 The Core Strategy 2007 sets out the policies for employment land provision and investment. The Economic Development Plan 2016 builds on this with an emphasis on delivering growth and diversification in the local economy. Being part of the Coast to Capital Strategic Economic Plan (SEP) enables the borough to build a long term vision which strategically aligns to those in the SEP that are relevant to the borough.

### 3 Proposals

- 3.1 The Local Plan Spatial Economic Growth Strategy aims to identify solutions for the provision of employment space to meet the borough's needs for economic growth and change within the plan period. It also identifies possible interventions, local plan policy changes and approaches required to deliver those solutions.
- 3.2 The Strategy identifies priority interventions to strengthen the borough's longer-term economic prospects, these include:
  - University Enterprise Zone and Creative Businesses Hub
  - Accelerated Redevelopment of the Utilities, East Street sites and Kiln Lane Industrial Estate
  - Longmead Office & High-tech Expansion Hub
  - Epsom & Ewell Cycle Network
- 3.3 The Strategy sets out the rationale for these interventions and the steps needed for their implementation, which includes the creation of an Enterprise Zone.
- 3.4 Supporting measures to achieve the aims include policies and development management guidelines for Epsom Town Centre, Longmead and Nonsuch, Ewell and Stoneleigh and The Downs.
- 3.5 The Strategy forms part of the evidence base for the new Local Plan, however it importantly sets out what is needed to create the conditions for investment and economic growth. The Strategy sets the direction and detailed business cases will be required for projects.

- 4.1 The Spatial Economic Development Strategy has been prepared within agreed budgets by external consultants Economic Growth Management.
