#### Terms of reference:

- 1. To attend meetings of the Task & Finish Group, contributing ideas, suggestions and proposals on the work already undertaken by the council administration on the Corporate Priorities and Future 40, and consulting wider networks of colleagues, peers and partners for feedback as appropriate.
- 2. To work together to develop a Place narrative for the Borough alongside a vision which can be used internally and externally.
- 3. To make recommendations to the Strategy & Resources Committee on the council's proposed Corporate priorities, five-year plan, and Place narrative.
- 5. To ensure that the five-year plan is linked to the Corporate Transformation Programme, Place narrative and the service review plan to address the shortfall in funding as recommended by the peer team. Ensuring that the vision and priorities drive the budget setting process.

- 6. To oversee and assist with any consultation and engagement activity with members, staff, partners and the public related to the Corporate priorities, Place narrative and five-year plan.
- 7. To support the peer challenge process by openly and honestly discussing and describing the work of the Task & Finish group to the peer team on re-inspection.

- 2. Work in partnership with fellow Task & Finish Group members and any other relevant or related Councillors, officers, partners or working groups, respecting one another's unique perspectives and contribution.
- 3. Have consideration to the council's Medium Term Financial Strategy and more long-term financial position when considering future priorities.
- 4. Have consideration to the councils Diversity, Equality and Inclusion Framework in developing the Corporate priorities, Place narrative and reviewing Future40, and consider the needs of those members of the community with protected characteristics throughout.
