Age				The consultation analysis suggests the targeted behaviours are more often exhibited by younger people and there is a risk that enforcement of the future PSPO will be perceived by these groups as having a negative impact. However, we also know¹ that younger people are disproportionally affected by ASB although are more inclined to view it as "normal" behaviour".  It is therefore expected that the impact on the protected characteristic of age is broadly

If adopted, this revised Public Spaces Protection Order will seek to control behaviours identified to affect residents of the borough:

- 1. Harassing or intimidating residents, businesses or members of the public.
- 2. Threatening any person with violence and / or being verbally abusive towards any person.
- 3. Wearing a piece of clothing with the intent to obscure or hide their identity for the purposes of committing crime and/or anti-social behaviour.
- 4. Acting, or inciting others to act, in an anti-social manner, that is to say a manner that is likely to cause harassment, alarm or distress to any person.
- 5. Joining or remaining in a group of 2 or more people which is acting in a manner that is likely to cause harassment, alarm or distress to any person.
- 6. Consumption of alcohol following a verbal warning by an authorised person to stop. An authorised person includes a Police Constable, Police Community Support Officer, a Council Officer, or any other person authorised by the Council.

The behaviours of urinating in an open public place and littering or spitting with the intent to cause harassment, alarm or distress to any person, are not proposed to be taken forward as part of the PSPO but were consulted on and assessed as part of this screening evaluation.

Adherence to legislation and relevant national guides ensures the PSPO targets qualifying anti-social behaviours undertaken by ALL and not by any one particular group. This arrangement ensures that the Human Rights Act is fully considered and adhered to ensure freedom of speech, association and religious belief are not targeted.

The focus around restricting behaviours, not people, and those new restrictions applying only to those without "reasonable excuse", ensure robust safeguards around equalities and civil liberties generally. It is therefore not intended to progress to a full Equalities Impact Assessment. Nevertheless, in the interests of transparency and accountability the following table is presented as mitigation to address the mild influence of the proposals on the two protected characteristics identified.

Issue	Action
Perception of targeting young people	Opportunity through a communications campaign to reinforce positive messages around appropriate behaviours and that to be applied universally. Timed to coincide with the deployment of required signage.  Opportunity via the User Voice and Participation Team to promote the positives to the demographic.
Perception of targeting men	Opportunity through a communications campaign to reinforce positive messages around appropriate behaviours and that to be applied universally. Timed to coincide with the deployment of required signage
