**Interpretations:**

<b>"the Act"</b>	means the Localism Act 2011;
<b>"body in which the relevant person has a beneficial interest"</b>	means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest;
<b>"director"</b>	<i>includes</i> a member of the committee of management of an industrial and provident society;
<b>"land"</b>	excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;
<b>"member"</b>	includes a co-opted member;
<b>"relevant authority"</b>	means the authority of the Member;
<b>"relevant period"</b>	means the period of 12 months ending with the day on which a Member gives a notification for the purposes of section 30(1) or section 31(7), as the case may be, of the Act;
<b>"relevant person"</b>	means a spouse or civil partner of a Member; or a person with whom a Member is living as a husband or wife or civil partner;
