**Interpretations:**

<b><i>“the Act”</i></b>	means the Localism Act 2011;
<b><i>“body in which the relevant person has a beneficial interest”</i></b>	means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest;
<b><i>“director”</i></b>	<i>includes</i> a member of the committee of management of an industrial and provident society;
<b><i>“land”</i></b>	excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;
<b><i>“member”</i></b>	includes a co-opted member;
<b><i>“relevant authority”</i></b>	means the authority of the Member;
<b><i>“relevant period”</i></b>	means the period of 12 months ending with the day on which a Member gives a notification for the purposes of section 30(1) or section 31(7), as the case may be, of the Act;
<b><i>“relevant person”</i></b>	means a spouse or civil partner of a Member; or a person with whom a Member is living as a husband or wife or civil partner;
<b><i>“securities”</i></b>	means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
